Between Daniel David of the Township of Kingston County of Frontenac Midland District and Province of Canada Yeoman[,] [and] a private in a flank Company of the 1st regiment of Frontenac Militia of the one part and Benjamin Babcock Jun^R of the same place Labourer of the second part Witnesseth that the said Daniel David for the sum of fifty pounds of the lawful money of the Province of Canada, to him in hand paid by the said Benjamin Babcock the Receipt whereof is hereby acknowledged hath Given, Granted, Bargained, Sold, Assigned, Released, Transferred, Conveyed and Confirmed, and by these presents doth Give, Grant Bargain, Sale, Assign, Release, Transfer, Convey and Confirm unto the said Benjamin Babcock his Heirs and assigns, All that certain tract or parcel of Land, situated in the Township of Hinchinbrooke in the County of Frontenac in the Midland District and Province of Canada Containing by admeasurement One hundred acres be the same more or less being Composed of the West half of Lot Number Thirteen in the first Concession of the said Township of Hinchinbrooke. To Have and to Hold the said above granted premises, with all the priviliges and appurtenances thereof to him the said Benjamin Babcock his
